




### Policy Management


The operative cockpit provides an overview and status display (red, yellow or green markings) of individual tasks. In addition, the process model provides a live display of which tasks have been completed and what steps need to be performed next. 
## Policy Management


Policy owners can maintain an overview and make even better decisions based on sound live data. Policies can be rolled out with the click of a mouse once all necessary releases have been completed in the system.
